

Optimizing NetSuite For Accounts Payable

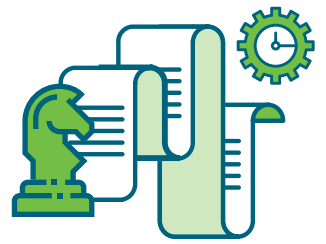

In order to operate effectively, an accounts payable team must set priorities and automate processes. Strategic Opportunities In Accounts Payable



Accounts Payable should not limit its goals to the simple task of paying bills on time. Instead, it has the potential to be a strategic operation that adds value to the entire company. Switching to a strategic view of AP will help an AP team establish and build trust with vendors, simplify the audit process, add value to the company, and improve short-term cash flow.

An inherent outcome of a proactive AP strategy is the **accretion of vendor trust**. Building strong vendor relationships can result in myriad benefits for the company:

- Lenience from the vendor in case a late payment is necessary.
- Additional negotiating power on contract terms and volume discounts.
- Leverage to ensure agreement terms are met and service quality remains high.
- Early access to new product offerings and product suggestions.
- Access to financing in case of cash flow difficulty.

Audits, typically viewed as onerous undertakings, provide another strategic opportunity. If AP teams don't have great organization, audits can pull employees away from their day-to-day jobs and require them to spend hours locating lost documentation while searching across a variety of locations. For this reason, audits provide an opportunity to identify gaps in operations and improve the process of keeping AP centralized and consolidated.

A strategic AP team adds value to the company as a whole by taking a proactive approach. At its most basic function, the team should be able to identify processes that can be improved or eliminated. Identifying inefficiencies that exist within your current process and altering them to become less time-consuming frees the entire team to move up to tasks with greater payoffs for the company. These [include](#):

- Focusing on improving discount rates with the most lenient vendors.
- Analyzing spending trends to discover areas in which the company can decrease overhead.
- Coaching vendors on invoice best practices to decrease overall invoice processing costs.
- Forecasting the amount of cash available to the company at any point in the future.

An improved command over short-term cash flow occurs only when a strategy is put in place that governs the precise timing with which bills are paid; the strategy should take into account relationships with vendors, discounts for early payments, and the latest possible payment deadlines. Optimizing cash flow in this way will enable a company to seize business opportunities with small windows, boost cash flow instead of simply managing it, increase operational efficiency, and achieve more rapid growth.

Each of these benefits are not possible if an AP team is only focused on paying bills on-time. But if AP is approached with a strategic mindset, and the team has set the right priorities, follows the right processes and uses the right tools, they will be able to improve the health and growth of the entire company.
